


Maximize your return - File your returns together




If you're married or in a common-law relationship, file your and your partner's return together in order to maximize the credits that you can claim. Filing a coupled return also makes transfering amounts between the two of you easier, and takes less time than if you'd prepare your and your spouse's returns separately.

Be aware of where you stand

Keep an eye on the left-hand navigation panel as you work through your return. Our software keeps track of your tax refund (or tax owing) in real time, so you can see the impact of everything you enter or claim on your return. Not only does this help you develop a better understanding of how things impact your return, you won't be blindsided by any surprises when it's time to submit your return to the Canada Revenue Agency (CRA) or Revenu Québec.



Know where to find help when you need it

Our <u>Online Help Centre</u> is available to all users of H&R Block's Tax Software. It's full of useful tax-related articles, FAQs, and other information to help make your tax filing experience as easy as possible. As you complete your return, you can access the Online Help Centre in a number of ways.

For example, let's say you're on a page and you're not sure what to enter. You can click a **NEED HELP** link to find out about a the page as a whole or a **LEARN MORE** for information about a specific field. Each of these links will guide you to the applicable resources within the Online Help Centre.


Optimizing your return

Reviewing and fixing errors

Not only will we help you correct errors as you complete your return, we'll also do one last check before you file to find any outstanding errors or missing information. Simply click the **Take Me There** button on the **ERRORS** page and we'll take you straight to the error:





Tip: If you're unsure how to fix an error, try searching the error code number (for example, **RQ140**), in the Online Help Centre for instructions.
