

## What is TDF?

Revenu Québec's **Téléchargement des données fiscales (TDF)** service provides a secure way to automatically fill-in certain sections of your tax return – saving you time and reducing errors caused by manual data entry.


To take advantage of this feature, you'll need to enter your **Notice of Assessment (NOA) number** and ensure the following information was properly entered in the **GET STARTED** section of the tax software:

- Social Insurance Number (SIN)
- Date of birth

Once that's done, you'll be able to download tax slips and other tax-related information right into your return!


**Note:** If you try to use the TDF feature and Revenu Québec has nothing on file for you, it might be because you're trying to download your information before Revenu Québec has had a chance to collect it, or you simply don't have any slips or other information available for download.

By waiting until the **middle of March** to download your slips, there's a greater chance that all of your information will be available.



## Where can I find my Notice of Assessment number?


Your NOA number can be found in the top right corner of your most recent Notice of Assessment:



## How do I use it?

Using TDF is both quick and easy. Once you complete the **GET STARTED** section of your return, you'll find yourself on the **QUICK ENTRY** tab.

When you're ready, click the **Get My Revenu Québec Data** button; you'll need to enter your Notice of Assessment number before your download can begin.

### You need to agree to Revenu Québec's terms and conditions

I understand that it is my responsibility to choose a directory where my data will remain confidential, to make sure the data is accurate and complete before I use it (to file my income tax return, for example) and to report all my income.
